TERMS & CONDITIONS

This Agreement is between the Applicant (hereinafter referred to as Exhibitor/s) and Stoller Holdings P/L Trading as Logistics Events Australia (hereinafter referred to as LEA)
By Completing and submitting this application, the applicant agrees that he/she has read and agrees to be bound by the terms and conditions listed below.

Payment

All Successful Exhibitors are required to pay a 50% reservation fee of the total cost within 5 working days of being notified. This deposit is mandatory for exhibitors to secure their site. The remaining balance is due no later than the 31st August 2015. If full payment is not received by this date LEA has the right to cancel their site for the Victorian Spring Garden & Lifestyle Show.

Application

- a) On submission of this application Exhibitor/s are to ensure that all appropriate documentation is attached.
- b) Approval of this application can take up to 2 weeks after the application has been received.
- c) The event organizers reserve the right to refuse any application to exhibit at the event at their absolute discretions.
- d) Once the application has been approved the exhibitor/s must make a 50% reservation payment (see payment section)
- e) The allotment of all site for exhibitor/s is at the sole discretion of LEA.
- f) The information provided in this application is correct at the time of publication, but is subject to change and revision in accordance with the requirements of the LEA.

Exhibiting / Operating

The exhibitor/s agrees that

- a) They shall confine all their activities to within their allotted site
- b) Their allocated site will be open and staffed for the total duration of the event as advised by the event organizers
- c) They will carry out and comply with all reasonable and lawful directions given to them by LEA, and to cooperate with LEA and any other officials in the event
- d) To only use their stall for the sale of legally permitted retail goods and approved activities
- e) To not cause any traffic hazard around their stall at any time.
- f) Exhibitor site must not be dismantled, removed either partly or fully within 24 hours of the closure of the event unless previously negotiated.
- g) Exhibitor will be responsible for the correct disposal of all waste throughout the event.

- h) At any point, during bump in, bump out or throughout the event if any damage is caused to the Mornington Racecourse facilities or grounds exhibitors will be held responsible.
- i) All Electrical equipment brought in and used throughout the event by exhibitor/s must be Australian Standard as well as have a c current Test & Tag. There will be onsite electricians through out the course of the event and if they deem any equipment to be unsafe or not compliant the event organisers have the right to refuse use of that equipment.

Cancelation

If Logistics Events Australia (has the right to do so) or the Exhibitor cancels their application to the event

- a) Prior to the 30/8/2015 they will be required to pay a 10% +GST administration cost that will be deducted from the paid deposit.
- b) After the 30/8/2015 they will be required to pay the full amount owed +GST except in the case of exceptional circumstances at the discretion of LEA.
- c) Notice of Cancellation will not take effect until it is received in writing from the exhibitor. If the notice of cancellation is received on a weekend or public holiday it will take into effect on the next working day.

If cancellation is to occur on the day/s of the event LEA will not be held responsible for any and all costs, damages and expenses, which are incurred by the exhibitor, employees and/or guests and. LEA will only be held responsible for any such costs, damages and expenses are caused or contributed by the neglecting acts of LEA.

Indemnities

- a) The Exhibitor/s shall fully indemnify LEA and hold them harmless in respect of all costs, claims, demands ad expenses to which LEA may be subjected to as a result of any loss or injury to any person/s or company/s including members of the public whatsoever, caused as a result of any act, neglect or default of the Stallholder.
- b) The Exhibitor/s acknowledge that no sponsors, event organizer and authorized persons are liable for any loss, damage or claim of any nature.

Food Health & Safety

- a) Application must comply with the requirements of the Food Act 1984
- b) The stall Holder/s shall observe and strictly comply with the public health and safety regulations
- c) All application have submitted and been approved for the Statement of Trade through the official streatrader website. Failing to do so will result in your application being withdrawn.
